

# MUSIC LESSONS AGREEMENT

## TERMS AND CONDITIONS

### 1. Fees

a) The Teacher will provide \_\_\_\_ -minute lessons for a fee of \_\_\_\_ per lesson, upon mutual agreement. (Please tick your option below).

b) Fees must be paid in full before or at the time of the first lesson. If the client requires fees to be paid in multiple installments, a mutual agreement will take place between the client and Kx2 Music.

c) Lesson fees are subject to annual review. Where Lesson fees are increased as a result of such a review, the Teacher shall endeavor to give the Parent/Guardian/Student at least two months' notice of such increase.

### 2. Lessons

a) Lessons will take place once a week, unless an alternative arrangement is mutually agreed upon.

b) Where the Student is under the age of 18, Lesson arrangements must be made between the Teacher and the Parent/Guardian.

c) Extra Lessons may be scheduled by mutual agreement between the Teacher and the Parent/Guardian/Student. An extra lesson that is not included in a package plan will serve as an Individual Lesson, and therefore, no discount will be provided.

### 3. Lesson Cancellation Policy

a) A minimum of 24 hours notice is required, otherwise, the client is responsible for full payment of the Lesson. Lessons canceled with appropriate notice will be rescheduled.

b) If the Teacher is unable to give any scheduled Lesson, the Lesson will be arranged for another date. If this is not possible, any fee already paid will be refunded.

### 4. Cooling-off Period

a) The Client has a legal right to cancel this agreement under the Consumer Contracts (Information, Cancellation and Additional Charges) Regulations 2013.

b) The Student's cooling-off period starts from the date of this agreement and ends 3 days later. To cancel the agreement during the cooling-off period the Parent/Guardian/Student should let the Teacher know that he/she has decided to cancel. The Parent/Guardian/Student will receive a refund for any Lessons paid for but not received prior to that cancellation.

## 5. Termination of agreement

A decision to discontinue lessons after the cooling-off period may be taken by the Parent/Guardian/Student, in which case, four weeks' written notice shall be given by the party seeking to discontinue. **In the event that the Student discontinues Lessons with insufficient notice, the Student/Parent/Guardian will be liable to pay fees for all previously completed lessons, which will be charged as Individual Lessons, as the applied discount will no longer be in effect. All remaining fees will be owed to Kx2Music within 7 days of agreement termination.**

## 6. General

- a) The Student/Parent/Guardian agrees to pay for any instrument purchase or repair required. The Student is responsible for the insurance of the Student's instrument, if applicable.
- b) The Student/Parent/Guardian will be responsible for any damage incurred by the Student to an instrument, accessory, or music owned by Kx2 Music.
- c) The Teacher will not enter the Student for any examination, festival, competition or other public performance without the approval of the Student/Parent/Guardian. Any entry fees for such examinations and festivals will be paid by the Student/Parent/Guardian.
- d) The Teacher must be informed of any medical or other condition affecting the Student.

## NOTES FOR GUIDANCE

*It is important to note that whilst a Teacher will use his or her best endeavors to ensure the Student makes satisfactory progress, this cannot be guaranteed. In particular, careful regular practice as advised by the Teacher is a prerequisite of success on any musical instrument or in any musical endeavor.*

**This agreement is subject to the conditions printed above and may only be varied with the agreement of both parties. The terms of this contract agreement are confidential.**

- If the Student is under the age of 18, the Parent/Guardian gives permission for the Teacher to teach the Student at lesson location (Student Home, Teacher's Studio, or Online), even if the Parent/Guardian chooses to not be present. (Please tick to consent).
